

Application for Participation in Instagram Wings Public Art Project

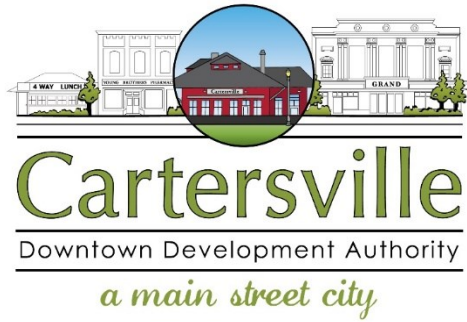
- Who?** Anyone is welcome to apply for this project.
- What?** This project is an effort by the Downtown Development Authority (DDA) to encourage public art in downtown. The purpose is to paint two sets of wings for an Instagram photo site that will be displayed in the downtown amphitheater and promoted on social media during our event and holiday season.
- Where?** The wings will be placed on two opposing concrete panels in our downtown amphitheater and repainted annually. The size of the panels is 40 inches tall by 95 inches wide.
- When?** The wings will be displayed from April 1, 2020 through February 28, 2021.
- Why?** To help improve downtown and bring more public art to Cartersville!
- How?** Submit an application for consideration to the Cartersville Downtown Development Authority by January 31, 2020. The winner will be announced at our annual meeting in February. Artist will have month of March to create wings.

Required for inclusion with your application (*incomplete applications will not be considered*)

1. The signed application agreement.
2. A conceptual rendering for both pieces to be painted.
3. A general budget and project timeline.

Additional project requirements

1. The DDA will pressure wash and prime the concrete surface in advance of the project but the artist will provide all other materials.
2. Artist agrees to use durable outdoor paint, suitable to the location and conditions of the project.
 - a. The DDA will provide a \$100 stipend for paint and materials at Sammy Morris Paint on Tennessee Street. Costs in excess of this amount, or spent at another location, will be the responsibility of the artist.
3. Artist also agrees to do any touch-up or repair work as needed while wings are displayed.
4. If chosen, the artist agrees to complete the project during the month of March. Projects not completed by April 1 will be subject to cancellation of the project agreement.
5. If chosen, the artist agrees to abide by the design presented in their conceptual rendering. Any variations must be approved by the DDA Director or Board or risk disqualification from the project.
6. Artwork may not contain any sort of nudity, profanity, violence, or other content deemed inappropriate by the Downtown Development Authority.
7. Artwork must be painted and may not include any items that must be affixed to the surface of the wall.
8. The DDA will have full ownership of the artwork including all rights of reproduction. Artist may display or reproduce piece for use in their own work.
